FJ WORLD CHAMPIONSHIP 2022

Regatta activities shall be carried out in accordance with the provisions concerning the fight against and the containment of the spread of Covid 19 issued by FIV, which the Organizing Authority shall be obliged to respect and enforce, and to which the participating members shall comply under the supervision of the Organizing Authority itself. Any cases of Covid 19 that may be detected during the event will be reported by the Organizing Authority to the relevant Health Authorities.

[NP] denotes a rule that shall not be grounds for protests by a boat. This changes RRS 60.1(a).

[DP] denotes a rule for which the penalty is at the discretion of the International Jury or Protest Committee.

1. ORGANIZING AUTHORITY

- 1.1** Under delegation of FEDERAZIONE ITALIANA VELA the championships are organized by **GEAS NBC Vela Colico A.S.D.** sailing club, Via Lungolaro Polti, 27/29, 23823 Colico (LC) Italy
- 1.2** Supporting club: **PerSport S.S.D.** sailing club, Via Lungolaro Polti 29, 23823 Colico (LC) Italy

2. LOCATION

- 2.1** The Open Italian Flying Junior Championship will be held in Colico (province of Lecco, Lombardy, Italy) on July 22-24, 2022.
- 2.2** The Flying Junior World Championship will be held in Colico (province of Lecco, Lombardy, Italy) on July 25-30, 2022.

3. RULES

- 3.1** The events will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 3.2** [NP][DP] *The "PROCEDURE FOR REGULATION OF ACTION TO STRUGGLE AND CONTAIN THE SPREAD OF COVID-19 IN AFFILIATED SPORTS CLUBS AND ASSOCIATIONS", current version - hereafter referred to as the "PROTOCOLLO". The penalty for a breach of the "Protocollo" shall be a maximum of 10%, depending on the seriousness of the breach committed. The percentage will be calculated with respect to the finishing position of the boat in all the races of the day in which the infraction was committed, or in case of an infraction while the boat is not racing, the penalty will be applied in the race nearest in time to that of the incident, as per RRS 64.2.*
- 3.3** If there is a conflict between languages, the English text will take precedence.
- 3.4** Appendix P of the RRS "Special procedures for Rule 42" will apply.
- 3.5** Appendix T of the RRS "Arbitration" will apply.

4. SAILING INSTRUCTIONS

- 4.1** Sailing Instructions will only be available on the official website and on the official notice board.

5. COMMUNICATION

- 5.1** The online official notice board is provided through manage2sail.com portal (see details on the official championship website www.fjworlds2022.it).
- 5.2** When flag V is displayed by the race committee with one sound, according to RRS 37, search and rescue instructions will be provided on a VHF channel. The channel will be communicated during the first skipper meeting at the beginning of the championships.

6. ELIGIBILITY AND ENTRY

- 6.1** The championships are open to all boats of the International Flying Junior Class that meet with the obligations of the Class Rules and their National Authority, in the case that a National Authority exists.
- 6.2** Online entry is possible through the manage2sail.com portal (see details on the official championship website www.fjworlds2022.it).
- 6.3** Complete entry deadline: July 21st, 2022 for the Open Italian Championship and July 25th, 2022 for the IFJ World Championship. A complete entry is when the payment of the applicable fee has been done. The applicable fee is the fee at the time of payment as per the fee scheme.
- 6.4** Entries shall be signed personally by the participants on the day before the beginning of each championship at 12:00 at the latest.
- 6.5** It will be possible to perform an entry after the deadline only with the Organizing Committee agreement.
- 6.6** All competitors (helmsman and crew) shall comply with the WS Eligibility Code.
- 6.7** Final registration is subjected to the presentation of following documents:
- the check-in report form duly signed (download pdf from the Manage2Sail portal after the pre-registration)
 - the disclaimer form duly signed (download pdf from the Manage2Sail portal after the pre-registration)
 - a valid Passport or ID-card for each person on board reporting picture of the person, name, surname, gender and date of birth
 - a valid measurement certificate
 - a valid third-party liability insurance (minimum 1.500.000 Euro)
 - the parent consent form for under 18 years old participants (download pdf from the Manage2Sail portal or from the official website)
 - foreign crews declaration that they comply with their Member National Authority regulations (download pdf from the Manage2Sail portal or from the official website).
 - Italian crews must show their FIV membership reporting a valid medical certification
 - the completed equipment measurement form duly signed by the measurer of the event at the end of the measurement/inspection procedure.

7. FEES

- 7.1** Entry fee per boat, to be paid by bank transfer at IBAN IT56K0200832540000103546297 bank account registered to GEAS NBC Vela Colico A.S.D.
- 7.2** The reason of payment shall report the following: "IFJ Worlds 2022/Open Italian _ sail number of the boat _ full name of the helmsman".

7.4 Entry fees are not refundable.

8. ADVERTISING

8.1 [NP][DP] Boats may be required to display bow numbers and/or advertising chosen and supplied by the organizing authority, according to WS Appendix 20. If this rule is broken, World Sailing Regulation 20.9.2 applies.

9. SCHEDULE

- 9.1** A total of 9 races are scheduled for the Open Italian Championship.
- 9.2** A total of 12 races are scheduled for the IFJ World Championship.
- 9.3** Maximum 3 races/day may be sailed.
- 9.4** If no races have been sailed and/or bad weather forecast may affect the IFJ World Championship validity, the Race Committee can decide to race 4 races in one day.
- 9.5** The scheduled time of the first warning signal for Open Italian Championship is 13:00 hours on Friday July 22
- 9.6** The scheduled time of the first warning signal for IFJ World Championship is 13:00 hours on Wednesday July 27
- 9.7** Last possible warning signal on Sunday 24 and on Saturday 30: 16:00 hours
- 9.8** A minimum of 4 races must have been completed to constitute a IFJ World Championship series
- 9.9** A minimum of 1 race must have been completed to constitute an Open Italian Championship series

10. EQUIPMENT INSPECTION

10.1 All boats will be checked for compliance with the Class Rules.

- 10.2** Measurement will take place as scheduled in the program.
- 10.3** Upon arrival or anyway within July 26 at 10:00 a boat representative is required to contact the registration office to get the equipment measurement form and to know the time the equipment must be presented for inspection
- 10.4** Measurement checks may be carried out at any time during the event.

12. THE COURSES

- 12.1** The courses shall be defined in the Sailing Instructions.

13. PENALTY SYSTEM

- 13.1** Rule 44.1 is changed so that the two-turns penalty is replaced by one-turn penalty.
- 13.2** For IFJ World Championship only, an International Jury will be appointed in accordance with RRS Appendix N.
- 13.3** For IFJ World Championship only, the decisions of the Jury will be final in accordance with RRS 70.5.

14. SCORING

- 14.1** According to RRS WS appendix A Low point scoring system will be applied.
- 14.2** Discards:
- when fewer than 4 races have been completed, a boat's series score will be the total of her race scores.
 - When from 4 to 8 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
 - When 9 or more races have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.

15. SUPPORT PERSON VESSELS

- 15.1** The entry form for support boats must be filled in and signed by the support boat responsible and must be approved by the Organizing Authority.
- 15.2** Entry deadline for support boats is July 26 12:00 hours.
- 15.3** The team coach boats shall conspicuously display their national flag and must comply with the coach boat regulations as defined in the Sailing Instructions. They must have a third-party liability insurance of € 1,500,000 worth.

16. CHARTERED OR LOANED BOATS

- 16.1** For chartered or loaned boats rule G3 will apply: a chartered or loaned boat may carry national letters or a sail number in contravention of her class rules, provided that the race committee has approved her sail identification before the first race.

17. BERTHING

17.1 [NP][DP] Boats shall be placed exclusively inside the official area designated by the club.

18. TITLES AND PRIZES

18.1 The following titles will be awarded:

- Top 3 overall teams in Open Italian Championship.
- Top 3 Italian teams in Open Italian Championship.
- First Junior Italian team in Open Italian Championship
- Perpetual Trophy for the Overall Winner – International Flying Junior Class World Champion 2022.
- Top 5 overall teams in IFJ World Championship.
- First Junior team in IFJ World Championship
- Special prizes might be awarded

19. RISK STATEMENT

19.1 RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue to race is hers alone". By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks.

19.2 The organizing authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

20. ENVIRONMENTAL RESPONSIBILITY

20.1 The Basic Principle is recalled, which states: "Participants are encouraged to minimize any adverse environmental impact of the sport of sailing"; it is recommended that care is taken to protect the environment at all times during and after the event. Especially, attention is drawn to RRS 47 -TRASH DISPOSAL- which states: "Competitors and support persons shall not intentionally put trash in the water. This rule applies at all times while afloat. The penalty for a breach of this rule may be less than disqualification".

21. INSURANCE

21.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 1.500.000€ per incident or equivalent.

22. ANTI COVID 19 MEASURES AND RELATED USEFUL INFORMATION

22.1 The organizing committee and all participants shall respect all the "COVID rules and restrictions" enforced by the Italian government and by Federazione Italiana Vela at the time of the race.

22.2 It is recommended to frequently check the Covid 19 emergency information web page at the following link → <http://www.federvela.it/emergenza-covid-19.html> where Federazione Italiana Vela regularly publishes any relevant update with regards to COVID-19 pandemic emergency, as descending from government and regulatory provisions that may be published later than this NoR. The "protocol" is also published at the link above. The latest version always applies.

23. MEDIA RIGHTS

23.1 Competitors automatically grant to the Organizing Authority and its Sponsors, without compensation, the perpetual right to make, use and show any text,

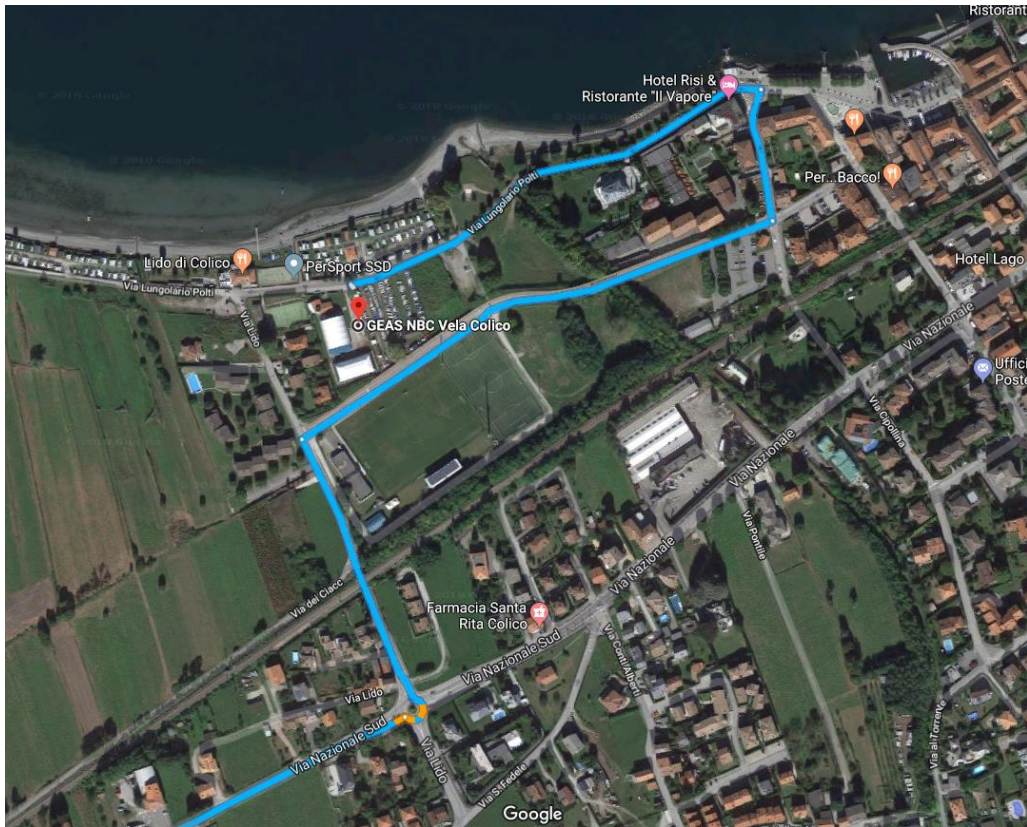
motion pictures, video and still pictures, as well as live, taped or filmed television of, or relating to, the Championships.

24. FURTHER INFORMATION

- 24.1** Accommodation: see the official website related page
- 24.2** Getting to the venue: see attachment A that shows how to reach the club from the main road (Via Nazionale) Detailed maps are available on the official website related page.
- 24.3** At arrival (attachment B – position 1) boats must be immediately dropped off, the trailers shall be taken over by organizing committee and parked in a special area (3), and cars/vans shall be parked in the designated area (2), while campers/caravans shall be placed strictly according to instructions by the staff.
- 24.4** News and information shall be found on the official championship website www.fjworlds2022.it
- 24.5** Starting from April 1st, 2022, news, updates and information will also be given through the “Telegram” App via the public broadcasting channel “FJ Worlds 2022”. During the championship this is intended to be the fastest way to communicate to participants, even if the Notice Board will remain the official communication medium.
